

Alumni Spotlight

Joey Feinstein, '94

Joey Feinstein never thought much about climate change until he met a North Dakota farmer during a cross-country bicycle trip. The farmer shared his concerns about the shifts he was seeing in weather and its impact on crops. This got Feinstein thinking.

The following spring, Feinstein graduated from the U of Illinois—Chicago with a BA in Sociology and began teaching at Rice Children's Center in Evanston. More than 80% of all children attending this school were wards of the state and lived in a residential facility attached to the school.

Despite the challenges

these children faced, Feinstein could never shake the feeling these kids weren't learning enough about the global challenges that currently affect them. After graduating from the Presidio School of Management with an MBA in Sustainable Management in 2007, he founded Climate Cycle.

Climate Cycle, a non-profit organization, was founded in 2008 out of a concern that today's youth lacked the tools necessary to respond to global warming



or benefit from the emerging green economy. Today, Climate Cycle leads the charge in catalyzing environmental education in our classrooms and communities by developing young leaders in sustainability.

Since 2009, Climate Cycle has inaugurated 11 solar schools. They receive solar systems and a dynamic school curriculum to maximize hands-on learning. The selected schools share a vision of climate solutions and energy independence from the students, faculty, administration, and beyond. Climate Cycle utilizes renewable energy because it is an available technology that provides tangible learning opportunities.

Feinstein credits his time at ETHS as being responsible for his ability to communicate easily with anyone, no matter their background, and an understanding of how powerful high school can be. While he didn't come to a full realization of what he wanted to pursue in his career until well after high school, he was able to think back to ETHS and realize what education should be.

From the Superintendent

How do you explain the ETHS advantage? by Dr. Eric Witherspoon

Alumni across the decades have recognized that
ETHS is a special place to attend high school and to make the important transition into young adulthood. Students flourish here, and alumni recognize the lifelong advantages of having graduated from ETHS. Yet, the ETHS advantage can be very difficult to explain to people who have not attended this high school.

I often try to explain the extraordinary value of an ETHS education and highschool experience. Here are some reasons I give to describe this awesome school:

Diversity. Most people from ETHS speak about our diversity as a major advantage, and for good reason. ETHS has been racially and socio-economically diverse since its founding. Sometimes our diversity is spoken about in idyllic terms, as if we've had diversity figured out for generations. We know that's not exactly the whole story. We've been trying to figure it out, but we know we've experienced difficulties addressing issues of race. But, that's only part of the story. What sets ETHS apart is that we don't stop trying, and now we are on a journey to truly achieve racial equity, social justice, and excellence for all students. We encourage and facilitate genuine conversations about race within our school and the community. Even if those conversations are sometimes difficult, this is a place to converse safely and to renew our commitment daily, striving to be a school where students of all races and backgrounds feel they belong and suc-

Acceptance. Differences are celebrated at ETHS. Students can find their niche and know it's okay to be themselves. Dark hair, blonde hair, or green hair—no problem. GBLT or straight—that's fine. Athlete, musician, YAMO performer, emo or preppy—you can be yourself. Math team, art show, Society for Hispanic Professional Engineers, book club, hip-hop club, or debate team—take your picks from dozens upon

dozens of choices. Acceptance among teenagers is not always perfect at ETHS, but I can't imagine any high school where acceptance of individuality and differences is as widely embraced as here.

High academic standards. Our academic standards have always been high, and they keep getting higher. Our teachers embrace continuous improvement, and they constantly collaborate to identify best practices and improve instruction. As a result, our courses reflect high academic expectations. Notably, many more students are being challenged academically, beginning as freshmen, and are preparing to take more honors and Advanced Placement (AP) courses. Today, we have the highest percentage of students in the school's history taking challenging AP classes.

Tradition of Excellence. ETHS has been one of the top high schools in the nation for decades. Back in 1968, ETHS was identified by *Ladies' Home Journal* as the top school in the nation. Forty-five years later we have had five consecutive years of the highest ACT scores in the school's history, and we're ranked in the top 2% of all high schools in the country by both *The Washington Post*

and U.S. News & World Re-

ports.

Abundant opportunities. You name it, we have it. Top music and theater programs. Top math and science departments. An interdisciplinary geometry and home-construction course. Adventure education. Chem-Phys. Bilingual education. Award-winning journalism and The Evanstonian. Twenty-seven AP courses. Senior Studies. Chinese and Japanese. The list of over 250 courses goes on and on. Plus, we offer 31 different sports as well as 104 student clubs and organizations.

Caring and inspiring faculty and staff. Name three adults who had a profound influence on you as a teenager, three adults who made a difference in your life. I'll bet nearly all Wildkits reading this named at least one ETHS teacher, coach or staff per-



son who had an important impact on them. ETHS has many caring and inspiring teachers and adults who have not only extraordinary instructional skills, but also establish positive relationships with students, helping them navigate not only their coursework but the challenges that teenagers face.

School pride and ownership. Recently, we held our spring pep rally. Pep rallies today are held after school, and students voluntarily stay to participate. About 2,000 students stayed after school on a Friday afternoon to cheer and show their exuberant school spirit. One of our alderwomen from the City of Evanston sat up in the Beardsley Gym bleachers, and her email to me pretty well sums it up. She indicated she wished others in the community could be there, "so they get closer to understanding—in one event, largely planned by students—all the good that happens within your walls. Let us simply sit anonymously in the bleachers and watch how our students cheer each other." Yes, it's pretty inspiring.

A community that highly values education.

Education is a top priority in our community. Local taxpayers provide 84% of our school funding to assure that students have the resources they need to enjoy the best high-school experiences and to learn at the highest level. This strong and generous support makes so much possible for our students.

So there you have it: some highlights from my list explaining the ETHS advantage. I'll bet every alum reading this can add your own reasons why ETHS is such an extraordinary place to learn and to grow into young adulthood why ETHS is unquestionably one of the finest high schools in the nation and has so many faithful alumni who have cherished memories of being an ETHS Wildkit.

What's New at ETHS?

ETHS ranked in top 2-percent in nation

In mid-April, *The Wash*ington Post released its annual national public school ranking called "America's Most Challenging High Schools," placing ETHS as 14th in Illinois, up one spot over last year, and in the top 2-percent in the nation. Four of the top Illinois schools are magnet schools, including Walter Payton College Prep. Several Chicago suburban schools ranked in the top 40, including Buffalo Grove (7), Hinsdale Central (8), Prospect (12), Libertyville (13), Fremd (17), Oak Park/River Forest (23), and New Trier (38).

For the past 15 years,

The Washington Post has rated the nation's public high schools based on a formula that includes the number of Advanced Placement (AP), International Baccalaureate and Advanced International Certificate of Education tests given at a school each year, divided by the number of seniors who graduated that year. Also noted are the percentage of students who come from lowincome families and the percentage of graduates who passed at least one college-level test during their high school career.

This year only 9-percent of the approximately 22,000 U.S. public high schools evaluated reached that standard and earned placement on the national list.

The following week,

U.S. News & World Report released its "Best High Schools" rankings for 2013. Again, ETHS placed in the top 2-percent of high schools nationwide and was awarded a gold medal based on factors such as state proficiency standards and how well students are prepared for college. More than 21,000 public high schools in 49 states and the District of Columbia were evaluated.

ETHS is one of only 19 high schools in Illinois, including magnet schools, to receive a gold medal for 2013. While schools with the highest college readiness were deemed goldmedal winners, the full criteria for the national and state rankings reflected how well high schools serve all of their students, not just those who are planning to go to college. In demonstrating measurable academic outcomes, ETHS ranked 18th out of 667 high schools in Illinois.

To cap off the month, The College Board named ETHS a 2013 Gaston Caperton Inspiration Award Honorable Mention school for promoting academic success and college readiness for all students, and for its innovative ability to inspire student success. ETHS will receive \$1,000 to apply toward programs that encourage students to attend college.

"To be one of only eight schools in the nation recognized by The College Board for the Inspiration Award is particularly meaningful because it acknowledges the importance of the work our faculty and staff are doing to achieve equity and excellence," said Supt. Eric Witherspoon. "We are making important strides in preparing all our students to take our most challenging honors and AP classes. Achieving equitable access to higher education and higher-level career readiness benefits all our students and benefits our community."



ETHS names new Assistant Superintendent/Principal



On March 18, Marcus Campbell, Associate Principal of Academic Affairs and Student Supports at ETHS, was hired as ETHS's new Assistant Superintendent/ Principal, effective July 1. He will succeed Oscar Hawthorne, who has resigned to take on new career opportunities after four years of service at ETHS.

Campbell brings considerable experience to his new position, all earned

from teaching and administrative assignments at ETHS. He began his career in education teaching English at ETHS. Three of these years he served as an AVID (Advancement Via Individual Determination) teacher and coordinator. In 2010-11, he was promoted to Special Programs Director, responsible for coordinating ETHS's student support programs: AVID, STAE (Steps to Academic Excellence) and Project Excel.

In 2011-12, Campbell became Director for Student Supports and Racial Equity, where he continued to oversee student support programs and was given administrative responsibility for the school's Wildkit Academy Saturday support program. In this role he also guided the District's racial equity work and professional development. Campbell was promoted to Associate Principal for Academic Affairs and Student Supports in 2012, responsible for Title I and all student support programs, curriculum and professional development for racial equity, and other related duties.

In his new role, Campbell will be the chief administrator for all school operations, responsible for administration of the educational program, building management, pupil personnel services, and oversight of all student activities.

Raised in Chicago, Campbell holds a bachelor's degree in English with a minor in African American Studies from the U of Illinois-Champaign, and a master's degree in Education, Social and Cultural Foundations in Education from DePaul. He anticipates defending a Doctorate in Educational Leadership and Supervision this spring.

ETHS Kudos

This winter and spring, many ETHS students and staff members were honored in a variety of ways.

STUDENTS

In science/math/ engineering...

In April, ETHS's Society of Hispanic Professional Engineers (SHPE) placed 8th in their division at the National Science Bowl, held in Washington, DC, and sponsored by the U.S. Department of Energy. Team members include Nancy Cardenas, Nikolai Lenney, Carla Orduno, Rosa Palma and Jean-Luc Walthall.

ETHS senior **Katie Latimer** was one of 20 students in the Chicago area who qualified for the U.S. National Chemistry Olympiad exam sponsored by the American Chemical Society. About 1,000 students, out of approximately 10,000 U.S. high school students, qualified to sit for the 3-part national exam.

ETHS students participated in an engineering competition sponsored by the Technology Student Association. This contest allows teams of students to apply their knowledge in science, technology, engineering and math to issues facing our global society. One team of ETHS seniors placed 1st in state in their division, 2nd overall in state, and nationally tied for 6th place. Another team of ETHS seniors took 2nd in state in their division, 3rd overall in state, and nationally tied for 7th place. These two teams placed the highest in the nation of any other Illinois schools in their division. A third team of ETHS juniors tied for 4th in state, ninth overall, and nationally tied for 10th place.

Seniors **Laura Goetz** and **David McDonald** qualified for the National Junior Science and Humanities Symposia after winning 2nd and 3rd place respectively at regionals. Both students won scholarships and earned trips to the natonal competition in May in Ohio. In the past 13 years, ETHS has had seven

state winners and two students who went on to represent the U.S. in London, England.

A team of ETHS seniors finished 5th in the nation in the Moody's Mega Math Challenge in April. ETHS students **Maggie Davis,** Caroline Duke, Laura Goetz, Katie Latimer and Dina Sinclair comprised the only finalist team from Illinois and shared a \$5,000 scholarship. This is the first time in the contest's history that an all-girl team made it to the national finals!

conference championship since 2000 with an overall record of 23-3 in the regular season and a 9-1 CSL-South record.

Wrestler **Brandon Vama- rasi**, a senior in the 220 lbs. weight class, won four straight matches in sectional play on one day to earn a trip to the state finals, the third ETHS wrestler in the past four years to earn a bid downstate, including Jeffrey Brown's heavyweight State Championship in 2010.

ETHS senior **Tiaira Scott**, a member of the ETHS wrestling team, won her first national championship at the U.S.A.W Girls Folkstyle National Championships held in Oklahoma City, OK, in March. Scott scored four wins in a total time of 5:58, with two wins over two opponents from Texas and two from California. She now moves on to freestyle competitions this spring and summer. Scott was featured in the April 22 issue of Sports Illustrated.

In February, ETHS was among 129 schools nationwide (15 from Illinois) named a GRAMMY Signature Schools semifinalist for 2013. Created in 1998, this nationally acclaimed program honors top U.S. public high schools that are making an outstanding commitment to music education through their total music curriculum and performance opportunities for students. Over 20,000 schools from districts across the country are annually invited to apply for this prestigious award. A

three-time recipient, ETHS was a GRAMMY Signature Schools Award winner in 2003, 2006, and 2009.

Finals, a vocal competition sponsored by the

Hotel. She received a \$500 scholarship. The contest resembles the hit TV series and was spearheaded by internationally renowned opera star Sherrill Milnes, who directs the final competition.

In February, ETHS junior **Talia Weiss** won 2nd place at the local level of the English-Speaking Union National Shakespeare Competition held at Roosevelt U. Twenty-two area schools participated. Weiss won a cash award and her sponsoring teacher, Anne Lefkovitz, received a toolkit for teaching Shakespeare.

In debate...

Junior Aaron Clarke finished 4th in Congressional Debate at this year's national Tournament of Champions. Clarke was among 115 students who qualified for this challenging event. This is the second consecutive year that an ETHS student has competed in the final round of Congressional Debate at the national tournament.

In chess...

Senior **Sam Miller** earned six wins and a draw to win his section at the Chess SuperNationals in April. Nearly 400 players competed in Miller's section.

In writing...

Nine *Evanstonian* staff members qualified for state finals and earned ETHS a 2nd-place finish at the IHSA journalism sectionals. ETHS junior **Rebecca Suennen** went on to capture 4th place in the state finals in yearbook layout/double-page spread. In addition, the *Evanstonian* earned a silver certificate from the Northern Illinois School Press Association.

STAFF

ETHS will be honored in July by the American School Counselor Association for establishing an outstanding school counseling program. ETHS will receive the Recognized ASCA Model Program designation at ASCA's annual conference in Philadelphia.

GionMatthias Schelbert, astronomy/physics teacher, is the 2013 recipient of the Harald Jensen Award. Schelbert is the first ETHS teacher to receive this peer award that honors teachers who use physics to inspire students as exemplified by Harald Jensen, a former faculty member of Lake Forest College.

On April 16, the Kiwanis Club of Evanston honored two ETHS staff members with the Hixson Award for outstanding service to the community. Mary Fifles Collins, '84, Community Service Coordinator, and **David Chan**, Technology Information Specialist, were recognized for their special efforts. Collins has worked with the Kiwanis Club on the Earth Day celebration and several other projects that have given students an opportunity to work with adults in the community as mentors and role models. Chan worked on the design of the Kiwanis Funville project that has encouraged students to find new ways to improve living in Evanston with an emphasis on fun.

Two concerts honor band director David Fodor

Two spring concerts will honor the retirement of Dr. David Fodor, director of Evanston Township High School's band and jazz programs for 22 years. And ETHS alumni will participate in the local celebrations on May 23 and May 25 as part of the tribute.

Fodor, who retires on June 14, will conduct his last ETHS band concert on May 23 in the high school auditorium. The spring band concert at 7:30pm is open to the public and will include an alumni band performance, followed by a reception. Tickets will be sold at the door at \$3 for adults, \$1 for students, and free to seniors and Booster members.

The May 25 concert is a free jazz program that will showcase jazz performances by alumni talent. The 8pm event and a reception with a cash bar will be held at the Unitarian Church, 1330 Ridge Avenue, in Evanston. This event will provide an opportunity for ETHS music families and returning alumni to pay tribute to Fodor's work.

ETHS students, an annual artist-in-residency program will be established at the high school. The David B. Fodor Musical Residency Program will be scheduled on a four-year rotation and will benefit all ETHS students in band, orchestra, chorus, and jazz. ETHS parents, alumni, current students, fans, community leaders and other friends of ETHS music are joining together to raise money for the Fodor Fund to launch the residency program. Donations are being handled by the ETHS Educa-

tional Foundation.

Alumni donations help support computer program, Poetry Week

Two ETHS programs supported in part by alumni donations recently reported success in inspiring students.

The Youth Technology Corps (YTC), a program that teaches students to refurbish donated computers which are then given to community organizations that need them, trained over 20 students this past year. Three-quarters of the students were some combination of minority, non-English first language, or special needs students, another goal of the program.

The students upgraded computers and set up wireless networks for Boo Coo of Evanston, Sunlight African Community Center in Chicago, and Bethel Church of Evanston, and they are making a 10-computer donation to the Youth Conservation Corp of Waukegan in time for Christmas.

This year YTC students are learning the Strata IT Curriculum, and will be able to earn this first level of professional certification once they pass a stringent test. Along with the technology skills

With help from the Alumni Association, YTC hired **Quinn McGee**, '12, the first YTC alum to come back as an intern as he continues his education.

Alumni donations also helped ETHS celebrate Poetry Week from April 1-5. Seventeen teachers and students in over 70 classes participated with guest poet Adam Gottlieb, who engaged the students in interactive poetry sessions and performances.

A culminating Open Mic session drew students to share their own poetry—some practiced and confident, some tentative and nervous—but all important presentations for everyone to hear and encourage.

Call for nominations: Distinguished Alumni Awards 2013

Include your own contact information. Once the nomination is received, the candidate will be asked to provide additional personal information. For multiple nominations, you must fill out a separate form for each candidate.

A Selection Committee will evaluate the nominations and select the recipients of the Distinguished Alumni Awards. All nominations will be kept on file and reconsidered for three years. After three years, a candidate must be renominated for consideration.

Deadline for submitting nominations is Monday, September 2, 2013.





It's the history of the legendary retail department store in London, and Jeremy plays American Harry Selfridge, the man who founded the eponymous store and "made shopping thrilling."

1990s

On March 24, Chicago writer, musician and educator Dr. Karl E. H. Seigfried, '90, was named winner of "Best Religion Weblog" in the 13th annual international Weblog Awards. It is the 2nd consecutive win for Seigfried's Norse Mythology Blog, which covers Norse myth and religion and features essays on all aspects of the mythology and interviews with major artists, authors, musicians and activists whose work is centered on Norse myth and religion. He teaches religion and music at Carthage College, where his Norse religion class is the first and only course on the subject taught in a U.S. religion department. He also teaches Norse mythology at Newberry Library and Loyola University Chicago. A featured writer and lecturer, Chicago music fans may be more familiar with his work as a critically acclaimed bassist and guitarist, playing and recording in virtually all musical styles. He has soloed with the Chicago Sinfonietta and Rockford Symphony Orchestra and is Principal Bassist of Chicago orchestras

including the Chicago Modern Orchestra Project and New Black Music Repertory Ensemble. As a jazz bassist he has performed with such diverse groups as the AACM Great Black Music Ensemble and the Glenn Miller Orchestra. A recording artist with 20 albums released, many of Seigfried's projects explore his interest in crossing musical boundaries and finding common ground between different music traditions.



Anders Holm, '99

Comic actor and writer Anders Holm, '99, a 2003 U of Wisconsin-Madison graduate, will be the speaker for spring UW commencement ceremonies in May. As a relatively recent graduate, Holm, thinks he can deliver a relevant message to the new grads. A history major, Holm credits communications classes he took his junior year with reigniting his passion for writing, film and TV. Holm is married to Emma Nesper Holm, a 2004 UW-Madison journalism grad who works as communications director for Venture Strategies Innovations in Irvine, CA. Holm is one of the creators, writers and stars of the Comedy Central sitcom "Workaholics." In the show, he and co-creators Adam DeVine and Blake Anderson star as three post-college roommates working telemarketing jobs by day and goofing off by night. The show is popular among 18-24 year olds, scoring an average of 1.4 million viewers in its third season. The show has been renewed for seasons four and five.

2000s



David Stillerman, '10

At the end of March, Carleton junior **David** Stillerman, '10, took over starting shortstop duties and moved up to the No. 2 spot in the Knights' lineup. He led Carleton to wins in each of its three games to close out its spring trip with at least three hits in each game. Overall, he batted .714 with seven runs scored, five RBI, two stolen bases and a pair of walks while only striking out once. His on-base percentage was .706 and he slugged .786 in the three victories. For his performance, Stillerman was named the Minnesota Intercollegiate Athletic Conference's Baseball Player-of-the-Week. He now owns a nine-game hitting streak, and has hit safely in all games but one this season. In 14 games, Stillerman is hitting .412 with 14 runs and 14 RBI. He ranks eighth in the MIAC in hitting, sixth in on-base percentage (.522), eighth in hits (21) and ninth in RBI.

Michael P. Fuller '71, a writer and Account Executive, livies in Atlanta, GA. Chronicles of a Nappi Head is his collection of tales to excite the spirit, reveal times and places you've never experienced, or simply bring back memories of past occurrences. The book takes you to a small town in South Carolina during the early 1920s, where a family man earned wealth while others in the town thought he should stay needy; to battles in Western France during World War II with a Negro Army squad in search of treasures; and to Chicago where you ride alongside a salesman for a day.

Daniel K. Berman, '72, has written The Newest Story of O: How to Legally Pay 0% Interest on the Money You Owe & Eliminate Your Debt in a Fraction of the Time—Secrets to Making the Credit system Work in Your Favor. Remembering Tosh, Goggins

Coach Jack Tosh, who served as ETHS assistant varsity football coach, sophomore basketball and sophomore baseball coach from 1960-68, died in mid-February. He graduated from Northwestern University (undergraduate and graduate degrees), where he also played baseball, and later taught at Lincoln, Nichols Middle School, and ETHS. Coach Tosh left ETHS in 1958 to become Athletic Director at DeKalb High School and finished his career in education as Athletic Director at York High School. He was inducted into the ETHS Athletic Hall of Fame in 2003 as an assistant coach of the 1968 State Championship Boys' Basketball Team.

Richard Goggins, Sr., **'50,** served as ETHS's Chief of Security from 1968 until his retirement in 1986. He passed away last year on June 20. He attended the U of Illinois-Champaign, U of Kentucky, and Georgia State University. During his career in public safety at ETHS, his staff grew, all sporting navy blazers, and carried walkietalkies to keep open the lines of communication, especially when the enrollment peaked over 5,100 in 1969-70. A commissioned Army officer, rising to the rank of Captain, he lived his dream of flying airplanes while serving in the Tactical Air Squadron in Korea. An Evanston resident for 43 years, Mr. Goggins moved to Atlanta, GA, in 1993.


